

1. The application is subject to jurisdiction of RUHS as decided by the State Government.
2. **Application for Affiliation alongwith Affiliation Fee will be accepted ONLINE through the official online portal of RUHS.** Hard copy of application and DD/Cheque for affiliation fee will not be accepted. There is no need to send the hard copy of online filled application form.
3. 18% G.S.T. will be applicable on total affiliation fees including penalty and late fees.
4. After receiving the online application for affiliation (complete application), the same will be processed by RUHS to grant the desired affiliation as per provisions of Ordinance 80 of university.
5. The affiliation letter for a particular course will be issued only if the college has produced the valid permission of the concerning higher council/commission, if applicable. Last date for submission of approval of concerning Higher Council to the university will be notified separately.
6. The online application for affiliation will be treated as rejected if required amount of affiliation fee is not deposited and the same is not accompanied NOC of Govt. (wherever applicable), no action will be taken by RUHS in this regard.
7. One time non refundable registration fee of **Rs. 10000/-** will be payable by the colleges applying for the first time for RUHS affiliation (i.e. New Colleges starting from academic session 2026-27).

**Other terms & conditions for affiliation of RUHS :-**

1. Every college situated under jurisdiction of RUHS and seeking affiliation of RUHS shall be abiding by the provisions of Ordinance 80 of RUHS *(as amended from time to time by RUHS)*.
2. Online Application for Fresh Affiliation or for seat increase in existing course must be accompanied with the valid NOC of the State Government *(wherever it is applicable apart from the other required documents)* for the applied course with annual intake.
3. RUHS will conduct the inspection of colleges as per Ordinance 80 for the desired courses as per the number of seats as mentioned in the NOC (wherever it is applicable) of the State Government and for other courses, where state Govt. NOC is not applicable, the number of seats mentioned in the online application for affiliation will be considered for inspection purpose.
4. Colleges will be intimated by email or through affiliation portal for the deficiencies pointed out by the university for fulfillment of the same. If the college fails to fulfill the deficiencies as pointed out by the university in the stipulated time period, then university will declare the session as a 'zero session' for such college.
5. In case of adjustment & refund of fees *(if applicable - due to withdrawal of application of affiliation or rejection of application for Fresh Affiliation)*, 10% amount of applicable fees will be deducted by RUHS from the deposited amount. Late fee and penalty deposited, if any, will not be adjusted/refunded.
6. In case of refund of affiliation fee, the refund will only be sent in the bank account of college which is mentioned in the online application form.
7. All colleges have to follow the ordinance/statutes of the university. No affiliated institution shall be allowed to discontinue the study of any course without prior permission of the University as per Ordinance 80.
8. The last date for withdrawal of application of affiliation is 15.12.2025
9. For closure of course(s), college has to apply through online affiliation portal alongwith required fee at least one full academic year in advance, giving the reason in support of the proposal & resolution of managing body for closure should be enclosed.
