Rajasthan University of Health Sciences for the Academic Session 2025-26

As per the recommendations of Finance Committee dated 29.11.2024 and further approval of Board of Management dated 23.12.2024, the schedule and fee for submitting the online applications for affiliation of Rajasthan University of Health Sciences for the academic session 2025-26 will be as follows:-

A. Time schedule for submitting online application for affiliation :-

For Fresh Affiliation (for starting of new course/college)/ Provisional Affiliation/ Annual Affiliation /Increase in intake of existing course)

B. Time schedule for submitting online application for 'Long Term Affiliation' for five academic years from 2025-26 onwards:-

Note :

- Application for Affiliation alongwith Affiliation Fee will be accepted **ONLINE** through the official online portal of RUHS. Hard copy of application and DD/Cheque for affiliation fee will not be accepted. There is no need to send the hard copy of online filled application form.
- 18% G.S.T. will be applicable on total affiliation fees including penalty and late fees.
- After receiving the online application for affiliation (complete application), the same will be processed by RUHS to grant the desired affiliation as per provisions of Ordinance 80 of university.
- Applicant College should submit the approval of Higher Councils through online portal **latest by 30.06.2025**, otherwise University will not consider the online application for grant of affiliation. For Faculty of Pharmacy, **last date will be 31.05.2025** for submission of approval of higher council (PCI, New Delhi).
- The online application for affiliation will be treated as rejected if required amount of affiliation fee is not deposited and the same is not accompanied NOC of Govt. (wherever applicable), no action will be taken by RUHS in this regard.

6. One time non refundable registration fee of **Rs. 10000/-** will be payable by the colleges applying for the first time for RUHS affiliation (i.e. New Colleges starting from academic session 2025-26).

Other terms & conditions for affiliation of RUHS :-

1. Every college seeking affiliation of RUHS shall be abiding by the provisions of Ordinance 80 of RUHS (as amended from time to time by RUHS).
2. A college presently having Annual Affiliation may also opt for 'Long Term Affiliation' for five academic years by depositing affiliation fee equal to 4.5 times of annual affiliation fee as per the Ordinance 80 of RUHS (as amended from time to time).
3. Online Application for Fresh Affiliation (for new colleges/new course) will be considered **upto 31.05.2025** with fresh affiliation fee (one time), provisional affiliation fee with maximum prescribed late fee & penalty in RUHS if the same is accompanied with the valid NOC of the State Government (wherever it is applicable apart from the other required documents) for the applied course with annual intake, and such complete applications will be processed by the university accordingly.
4. In case of seat increase, prior approval of concerned higher council and permission of state government (wherever necessary) are required and the fee for seat increase **upto 31.01.2025** will be collected from college as per prescribed fee structure. However, if any permission for seat increase is received **during 01.02.2025 to 28.02.2025**, then seat increase fee will be collected with late fee and penalty in the same multiple as being done for annual affiliation fee (as per decision of AC 04.07.2016).
5. RUHS will conduct the inspection of colleges for the desired courses as per the number of seats as mentioned in the NOC (wherever it is applicable) of the State Government and for other courses, where state Govt. NOC is not applicable, the number of seats mentioned in the online application for affiliation will be considered for inspection purpose.
6. Colleges will be intimated by email for the deficiencies pointed out by the Board of Inspection for fulfillment of the same. If the college fails to fulfill the deficiencies as pointed out by university in the stipulated time period (15 days), then university will declare the session as a 'zero session' for such college.



7. In case of adjustment & refund of fees (if applicable), 10% amount of applicable fees will be deducted by RUHS from the deposited amount. Late fee and penalty deposited, if any, will not be adjusted/refunded.
8. In case of refund of affiliation fee, the refund will only be sent in the bank account of college which is mentioned in the online application form.
9. After inspection of college by the University, the affiliation fee (other than one time fresh affiliation fee) will not be adjusted/refunded to the college.
10. All colleges have to follow the ordinance/statutes of the university. No affiliated institution shall be allowed to discontinue the study of any course without prior permission of the University as per Ordinance 80. An application for such permission shall be made to the Registrar, RUHS by the Head of the Institution duly forwarded by the Management at least one full academic year in advance, giving the reason in support of the proposal & resolution of managing body for closure should be enclosed.
11. If any college which is under provisional/annual affiliation of RUHS, fails to apply in RUHS for a particular academic session upto the last date, then in such case the defaulting college will be declared 'De-affiliated' for such academic session. When such college apply for next academic session after such gap of one session's de-affiliation then the such college has to deposit the 'Fresh Affiliation Fee' again in RUHS as applicable for the concerning course for the related academic session along with other applicable fee and last session's affiliation fee with maximum penalty & late fee.
